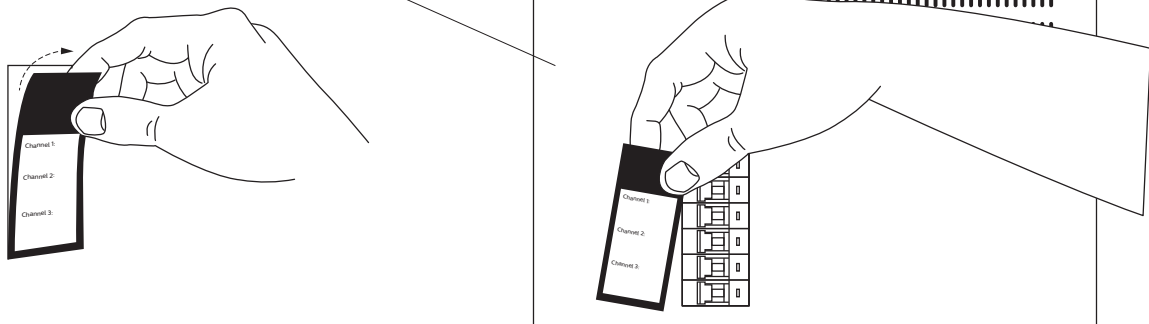


IEC Overvoltage Category III
