

Limited Warranty: PILA Luminaires

Signify North America Corporation ("PILA") warrants to the original purchaser ("Purchaser") that the PILA branded luminaires identified on Schedule 1 ("Products") will be free from defects in material and workmanship which cause the Product to fail to operate in accordance with the performance specifications set forth in documentation published for or provided with the Product ("Specifications") for the applicable period and subject to the additional terms and conditions set forth on Schedule 1 from the date of purchase (as set forth in the applicable invoice) ("Warranty Period").

PILA warrants that any standard finish on a Product will be free of cracking, peeling, excessive fading, and corrosion defects during the applicable Warranty Period. To the extent that an authorized PILA distributor is the Purchaser of the Products, such distributor may transfer this limited warranty to subsequent purchasers of the Products, provided that such Products are resold in new condition and in their original packaging. Third party components incorporated into the Product that are not manufactured by PILA are excluded from this warranty, but may be covered by a third party manufacturer. Such third party manufacturer shall be solely responsible for the costs related to any claims associated with any such component. For non-LED Products, ballasts and lamps manufactured by PILA are warranted separately and the terms of such warranties are located at www.pila-led.com/en-us. For LED Products, the Product shall be considered defective only if 15% or more of the LED components fail for such Product. Certain luminaire components may be adversely affected by contaminants. If sulfur, chlorine, or petroleumbased solutions, or other contaminants will be in the area of operation, please consult factory as damage caused by these contaminants are not covered under our warranty.

If any Product covered by this limited warranty is returned by Purchaser in accordance with PILA Terms and Conditions of Sale (available at www.signify.com/warranties) within the Warranty Period, and PILA determines to its satisfaction that such Product failed to satisfy this warranty, PILA will, at its option, repair or replace the Product or the defective part thereof, or reimburse Purchaser for the purchase price, subject to the terms and conditions set forth herein. For purposes of clarity, "repair or replace the Product or the defective part thereof" does not include any removal or reinstallation costs or expenses, including, without limitation, any labor costs or expenses, shipping costs to return non-conforming Products or any dam- ages that may occur during the return of Product to PILA. If PILA chooses to replace the Product and is not able to do so because it has been discontinued or is not available, PILA may replace it with a comparable product. PILA reserves the right to use new, reconditioned, refurbished, repaired or remanufactured products or parts in the repair or replacement of any Product covered by this limited warranty.
