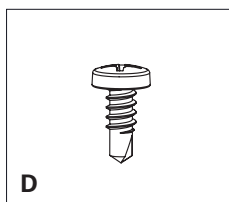
A Joiner Plate



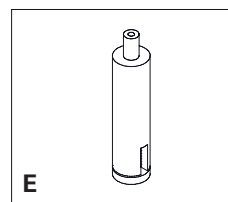
B 1/4-20 Cap Screw



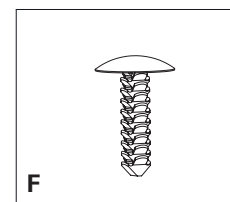
C Strain Relief



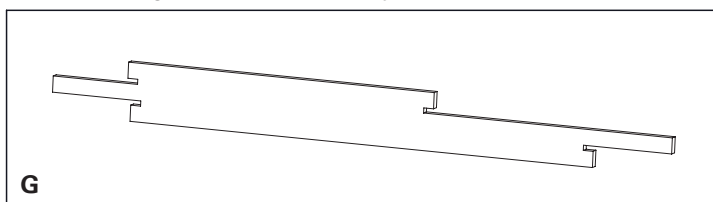
D #10 Drilling Screw



E Cable Adjuster

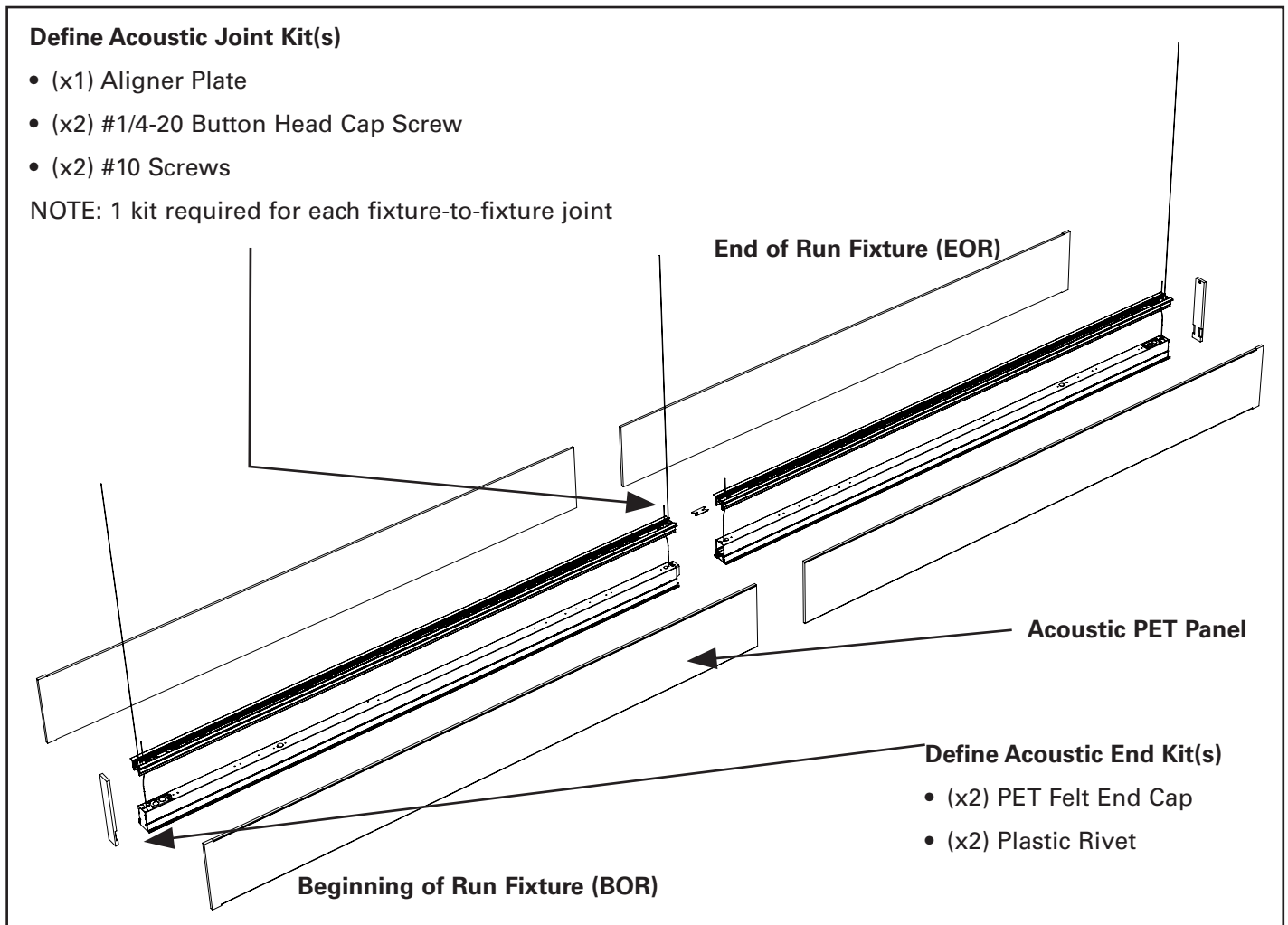


F Plastic Rivet



G Installation Tool

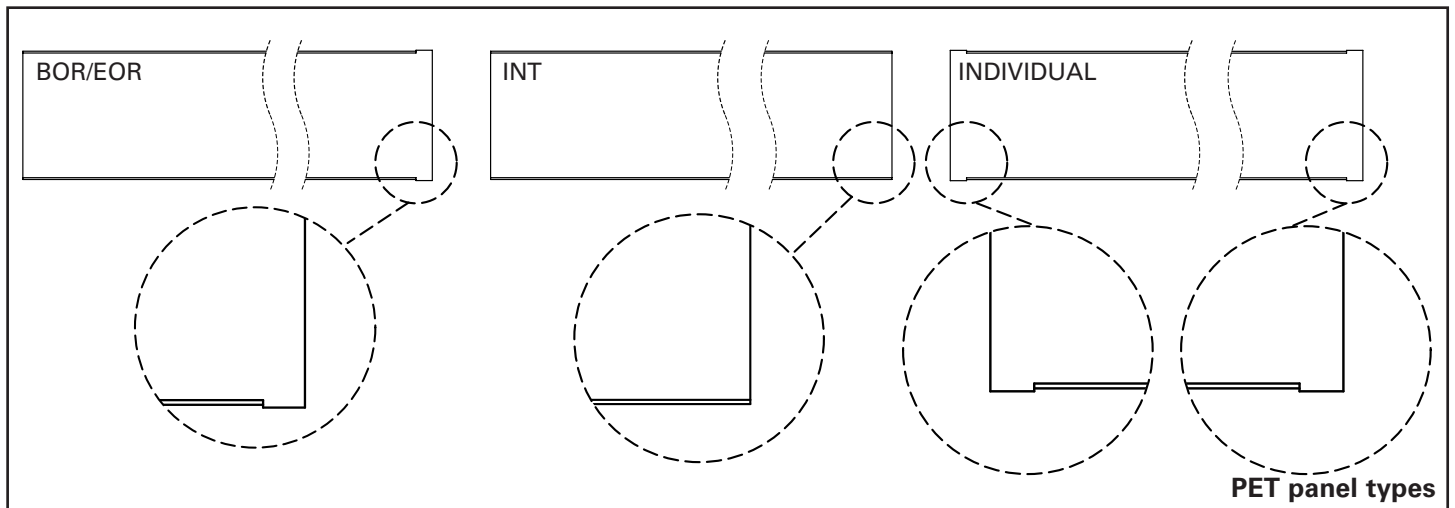
System Overview



To begin installation:

Locate the beginning of run (**BOR**) fixture. Intermediate and end of run fixtures are marked with **INT** and **EOR** labels respectively. Below are the PET panel types that accompany each fixture.

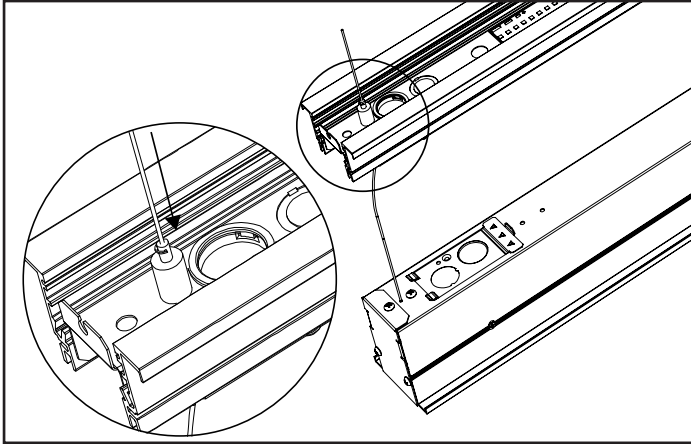
Unpackage the **BOR** fixture from the box setting aside the PET end cap for later in the installation.



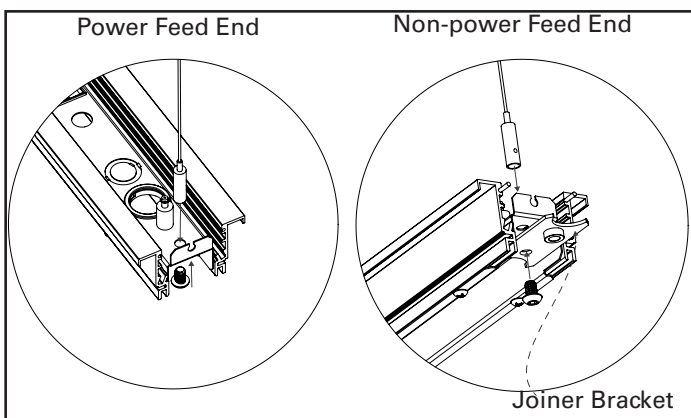

① Upper Assembly installation

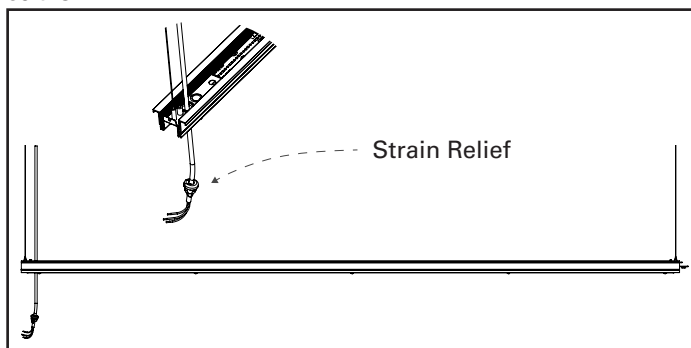
Disengage the reverse release Griplocks and pull the aircraft cables connecting the upper and lower assemblies out of the upper assembly to separate. Disconnect the low voltage connector between the two assemblies. These will be reinstalled later during the installation.



Using the hardware included in the installation Hardware package install Griplocks into the upright utilizing the 2 holes located closest to the ends of the upright tray. For the power drop side install the Griplock using the included 1/4-20 thread locker screw.



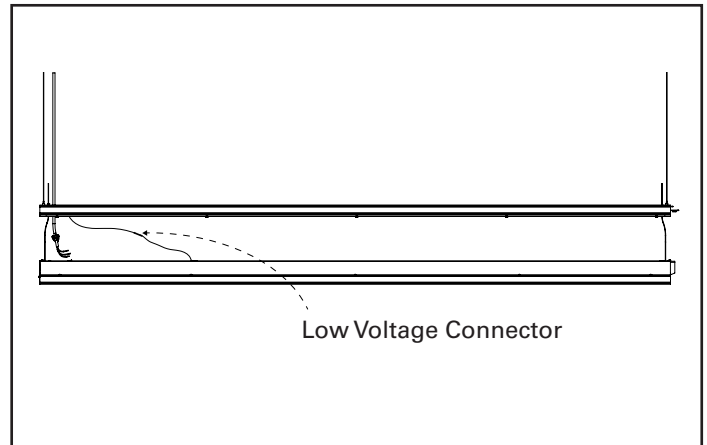
Hang the upper assembly of the BOR fixture and pass the SJ cable through the exposed hole in the fixture as shown. Place the provided strain relief on the SJ cable.



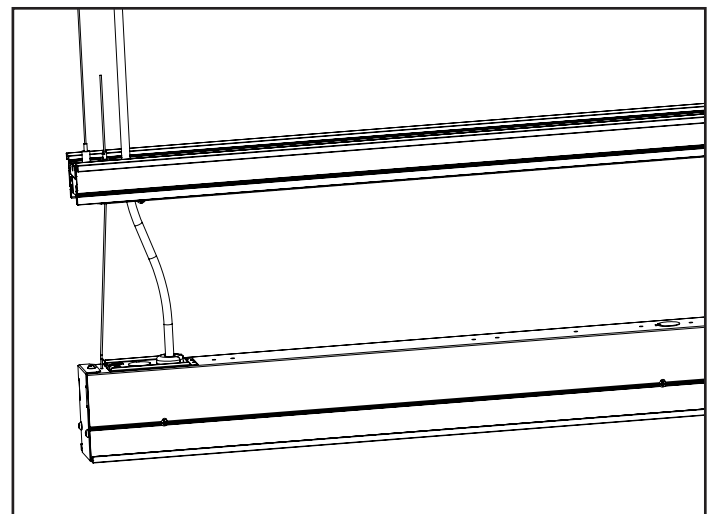
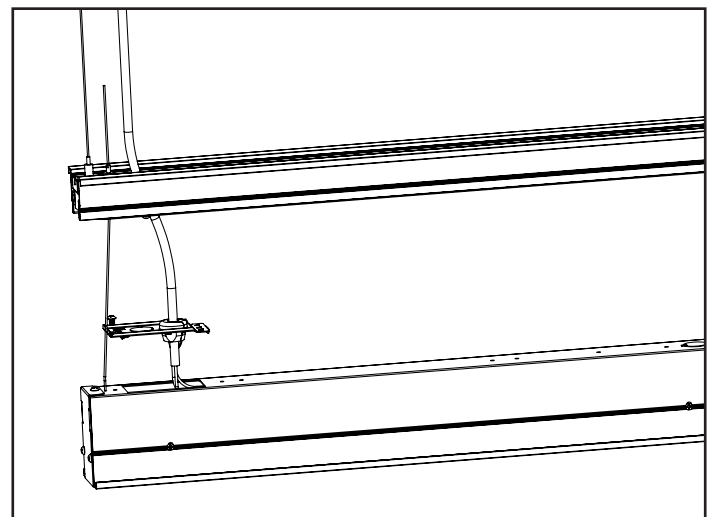
For installation at ceiling, see separate ceiling interface instructions.

② Lower Assembly Installation

Attach lower assembly of fixture using the aircraft cable and re-connect the low voltage connector between the upper and lower assemblies.



Remove #8-32 screw to release access plate and pass the SJ Cable with Strain relief into the hole in the access plate as shown. Make connections to corresponding wires in the fixture and replace access plate.



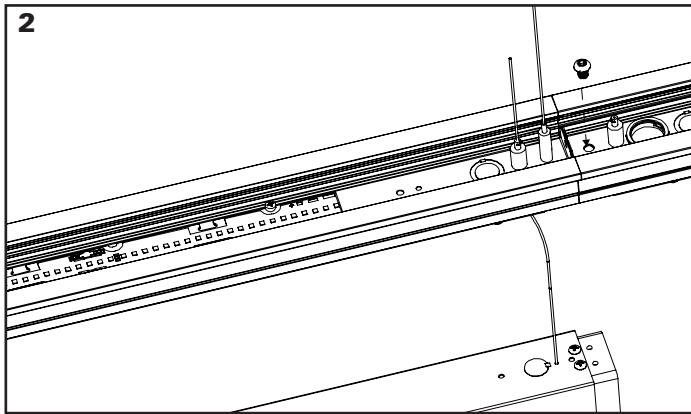
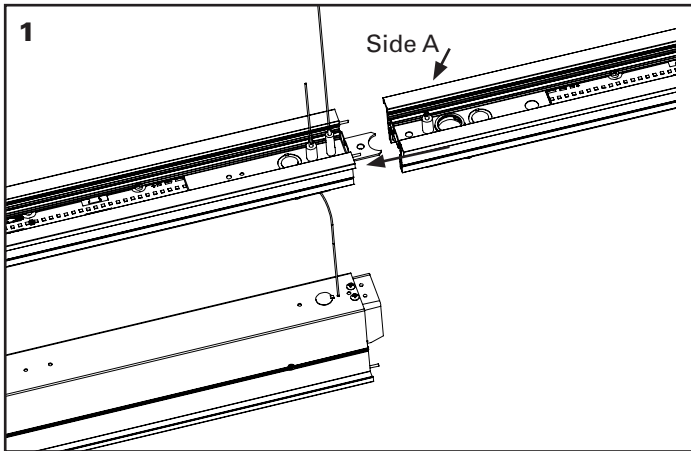

③ Joining

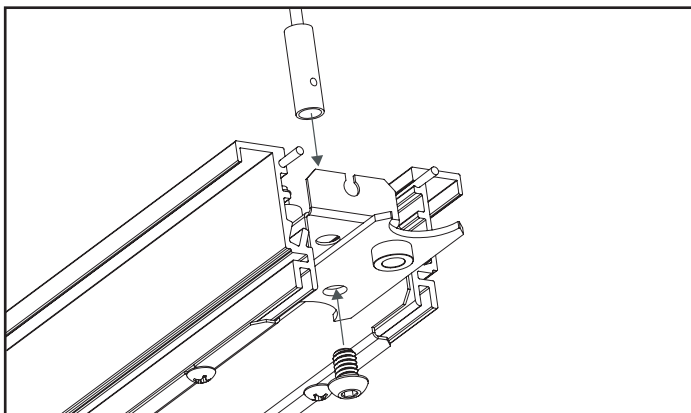
Unpack the INT or EOR fixture and separate the Upper and lower assemblies as described in step 1. The upright tray has a large opening at one end. This shall be referred to as side A.

Rest side A on the protruding joiner bracket (as shown below) and support the other end of the fixture.

Secure the join with the provided #1/4-20 Button Head Cap Screw

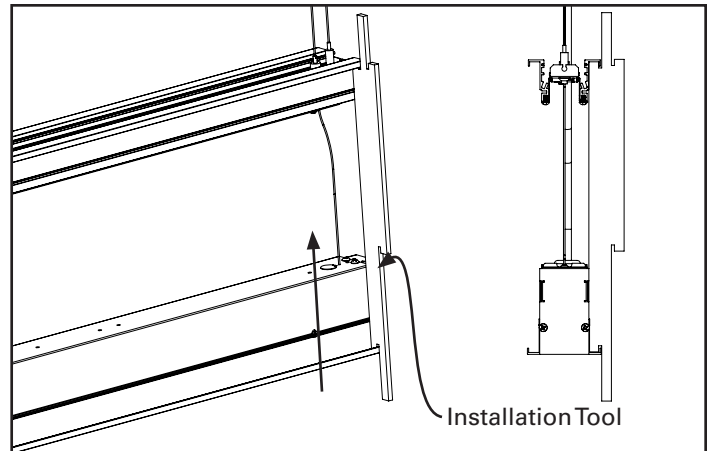


Install Griplock and Aircraft Cable on opposite end of the upright assembly and level the fixtures



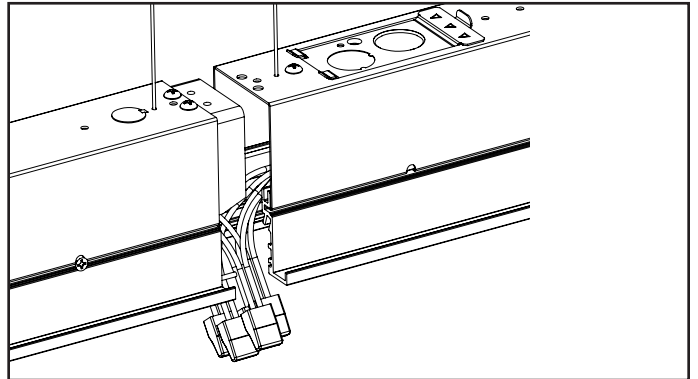
④ Joining the Lower Assembly

Set the height of the downlight assembly on the BOR fixture using the Installation Tool provided and tighten the aircraft cable to achieve the desired height.

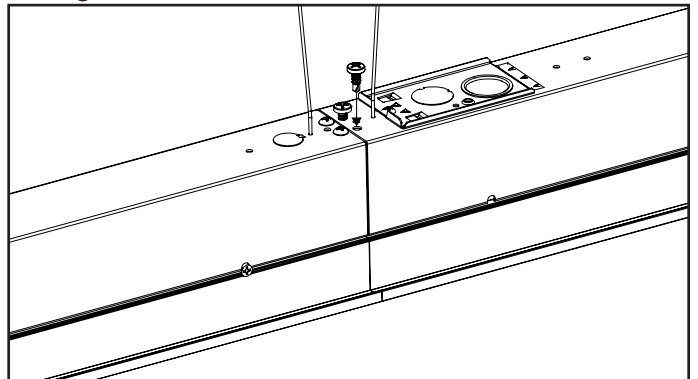


Attach the downlight using the pre-installed aircraft cables, raise into position until approximately level with the installed fixture.

Join the through wires using the provided connectors.



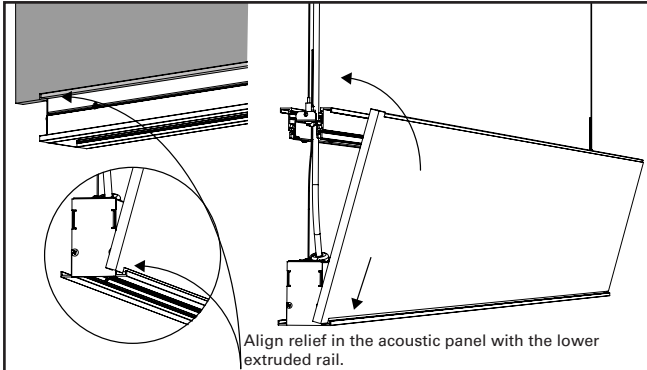
Tuck the connected through wires into the wiring compartment and push the fixtures together as shown below. Secure the fixtures using the provided **#10 Drilling Screws** as shown below



At this point fixture installation may be halted. This is the completion of the "light first" install. The light will function and operate as normal but will not have any acoustic properties. This is useful during new construction as the acoustic panels may collect dust and debris that can be difficult to remove

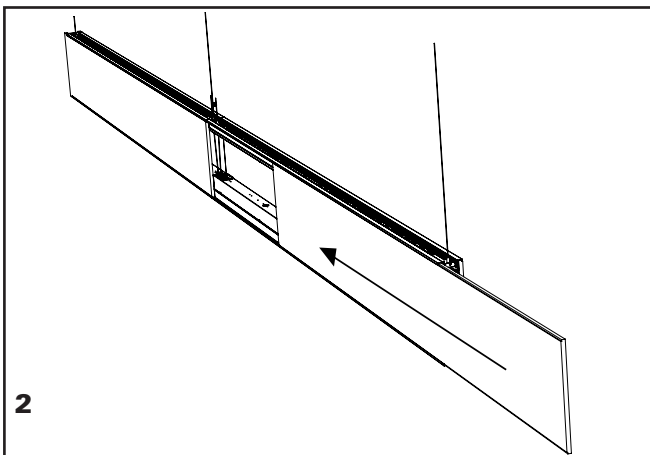
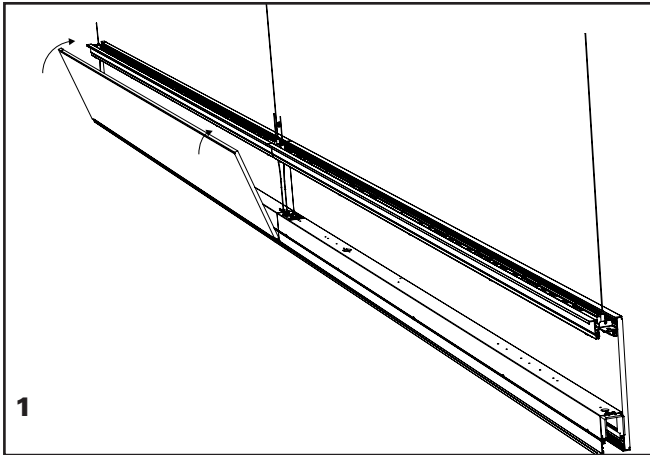
⑤ Acoustic Panels

Install a single acoustic panel into the downlight housing on the BOR or EOR fixture working your way from one end to another. Begin by aligning the relief in the acoustic panel with the lower extrusion rail. Ensure that the panel is installed along the entire length of the extrusion.



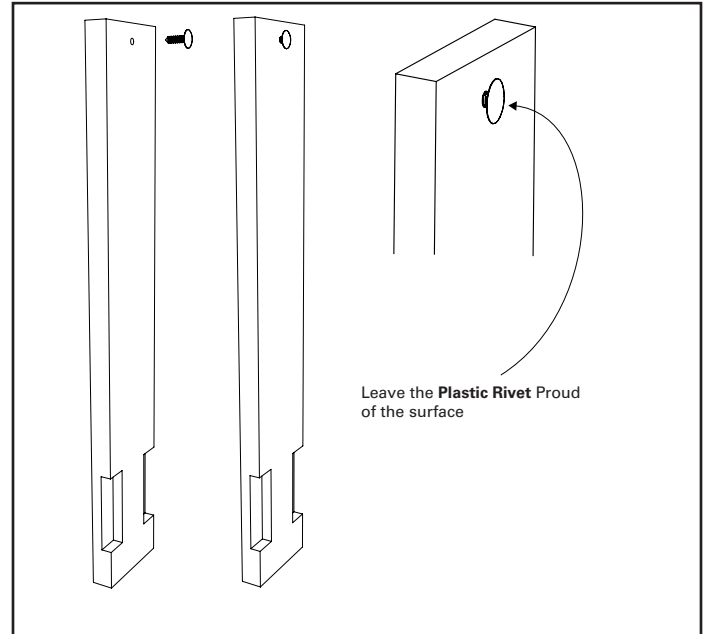
Complete the process by continuing along the length of the run.

Note: in installations with significant room on the end of the run it may be easier to slide the acoustic panel into the fixture on both the uplight and downlight simultaneously (2).

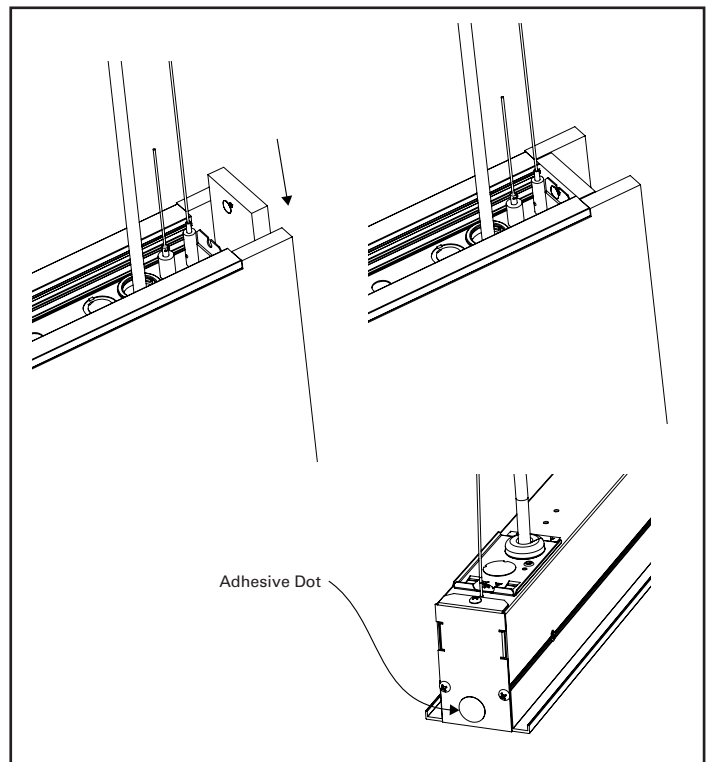


⑥ End Cap Installation

Install a Plastic Rivet into the end cap in the corresponding hole. Do not press the Plastic Rivet flush, leave it proud, with room for the end cap to be slipped onto the upright tray as shown below.



Install the end caps onto the fixture by first sliding the end caps downward onto the fixture, engaging the Plastic Rivet into the corresponding slot and then pressing the end cap flush with the adhesive dot installed on the fixture.
