- Implement preventive practices and responsive procedures regarding incidents, near misses and emergencies.
- Meet or exceed the requirements of applicable EHS national regulations
- Provide all employees with relevant information and regular training on EHS aspects
- Consult and cooperate with employees and/or their representatives as well as other internal and external stakeholders
- Be fully transparent in our periodic reporting on EHS performance
- Apply systematic continuous improvement activities at all levels in the organization to achieve a zero-injury workplace with minimal environmental impact.



Environment

We focus on prevention and minimizing the impact of our operations, business, and supply chain on the environment. We are committed to continuously exploring opportunities and solutions to further decrease our environmental impact in a technically and economically-feasible manner. The environmental performance of our operations focuses on carbon neutrality, 100% renewable electricity, zero waste to landfill, and protecting nature by preventing pollution, reducing emissions to air, soil, and water, minimizing the use of water, and preserving biodiversity.

The environmental performance of our lighting solutions focuses on the areas of climate action and circular economy, which are an integral part of our company strategy. In this way, we also help to reduce the environmental impact for our customers. We evaluate the environmental performance of our products over their total life cycle and apply sustainable design principles in our innovation process so that product and system designs take energy use, circularity, weight & materials, packaging, and substances into account.

We work with our supply chain on environmental responsibility, driving compliance and improvement through audits and training in at-risk countries. Our programs in the supply chain additionally focus on substance management, conflict minerals, and support to reduce our suppliers' carbon footprint.

Our employees, temporary workers, contractors, and visitors have the right to a safe working environment. We proactively work toward a zero-injury workplace through injury prevention. We aim to continuously recognize and eliminate hazards in the workplace before an occupational injury or illness occurs. We believe that through a consistent effort all occupational injuries and illnesses can be prevented.

All individuals within our company share a responsibility to prevent any harm to themselves, fellow employees, contractor employees, our business partners, and the environment.

Health and Safety, driven by our Integrity Code and 10 Golden Safety Rules, form an integral part of doing business and must be incorporated into every action we undertake. We do not accept any at-risk activity at any level of operations, at Signify premises and customer sites.

Measuring our progress

Signify EHS management systems operate in accordance with the international standards ISO14001 and ISO45001. We use audits for a systematic and documented verification process that ensures compliance and drives continuous improvement. Signify measures and verifies by a third party its environmental performance and publishes validated results annually. We publish lawful environmental achievements and product claims and make our EHS Policy available to employees and other internal and external stakeholders.

Signify is committed to comply with all applicable laws and regulations, will promote international harmonization of applicable laws and regulations, and is prepared to enter into voluntary agreements. We expect our business partners to uphold a similar standard.
