

AGM 2021 VOTING RESULTS

Summary of resolutions taken at the Annual General Meeting of Shareholders of Signify N.V. held on Tuesday May 17, 2022 (the "**AGM 2022**").

On April 19, 2022, after processing of all settlements of that date (the Record Date), the total number of issued shares in Signify N.V. was 128,344,238 ordinary shares. Considering the number of shares held in treasury, which amounted to 4,267,051 on that same date, the number of voting rights amounted to 124,077,187.

The total votes present or represented at the AGM 2022 was 99,564,670, which is 80.24% of Signify's issued share capital that can be voted on as at the Record Date. Percentages in this summary have been rounded.
